## **EXCITING ENDEAVORS FOR THE FOUNDATION OF ALA**

The Foundation of the Association of Legal Administrators is ALA's charitable education and research affiliate organization that pursues advancement of the profession by sponsoring education, publications, research and worthwhile ALA chapter projects. On behalf of the Foundation's Board of Trustees, I want to share some highlights from 2015 and look forward to our activities in 2016.

Thanks in large part to the support of ALA members and our business partners, the Foundation continues to play an important role in the educational programming of our Association through sponsorship of events like the David W. Brezina Memorial Session at the Annual Conference & Expo.

The Foundation also continues its annual Silent Auction at Annual Conference, which serves as a major funding source. We look forward to an even more exciting auction this year, as we introduce a new online auction feature.

Additionally, the Foundation provides support and funding to ALA chapters as part of the chapter grant program. We are very proud of the Greater Phoenix-Valley of the Sun Chapter for creating an updated #BizLaw in a Flash study app through Apple and Google Play. A key project we continue to focus on is our partnership with the Legal Services Corporation (LSC). The LSC provides civil legal services to those who cannot afford legal representation. To date, close to 60 nonprofit members received complimentary ALA membership from the Foundation, and we hope to increase our visibility with the LSC in 2016.

One project the Foundation is very passionate about is the Susan French Emerging Leader Scholarship Fund that was established by GLJ Benefit Consultants in memory of former ALA President Susan French. The fund is in recognition of French's commitment to professionalism, dedication to the advancement of law firm administration, development of future leaders and record of long-term service to ALA. We were very happy to award one scholarship to attend the Annual Conference & Expo in Nashville, two scholarships to the Chapter Leadership

Institute (CLI) this past July, and a scholarship for one member to attend Law Firm Management Essentials.
