### Diversity and Inclusion Bottomline

- Among companies with more than \$10 billion in annual revenues, 56 percent strongly agreed that diversity helps drive innovation.<sup>1</sup>
- Diversity is an area in which law firms have traditionally not competed well.<sup>2</sup>
- When teams had one or more members who represented a target end user, the entire team was as much as 158% more likely to understand that target end user and innovate accordingly.<sup>3</sup>
- The importance and value of a more diverse and inclusive legal profession goes well beyond dollars and cents. A diverse and inclusive legal profession is fundamental to social justice.<sup>4</sup>
- Diversity is associated with increased sales revenue, more customers, greater market share and greater relative profits<sup>-5</sup>

#### Beyond Diversity: Inclusion = Success

- Inclusion is more than a program; it should be woven throughout every aspect of an organization's philosophy.
- The best way for firms to support women and diverse attorneys is to have a leadership structure that features attorneys like them. When diverse lawyers look up, they want to see successful women, black, Latino, Asian and LGBT leaders. They want to know that there's an opportunity for them, too, to reach that level.<sup>2</sup>
- An inclusive platform for diverse attorneys to succeed – supported and funded by the firm – may identify and propel a new generation of leaders that reflects demographically what law firm management should be.<sup>2</sup>
- In most law firms, professional development and diversity and inclusion are separate initiatives. Instead of having committees for both, invite a group of lawyers and professionals from both areas to join an advisory group to share perspective and thoughts, and then ask participants to set a living example for others.
  While subtle, the minor change can be a powerful way to shift the focus to behavioral outcomes.<sup>6</sup>
